KEY PLAN - UNIT LOCATION

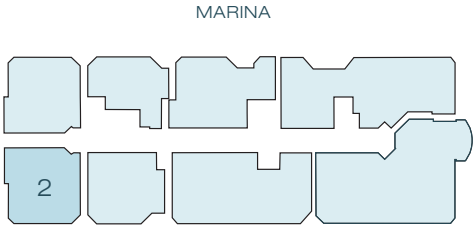

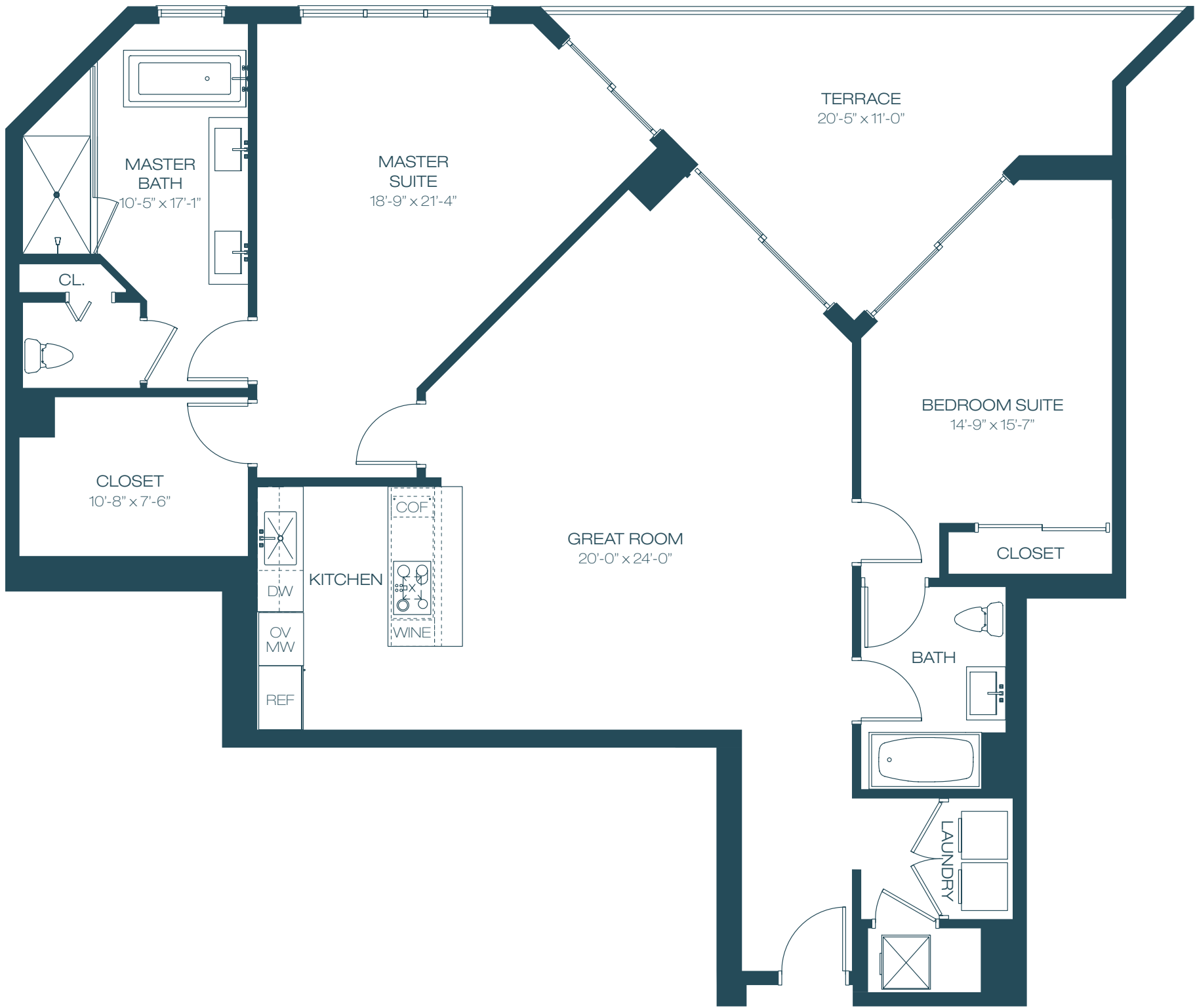

 KEY PLAN - UNIT LOCATION

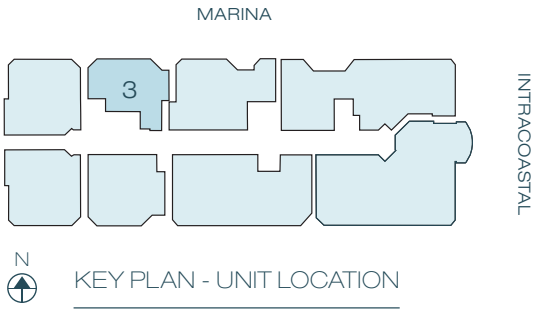

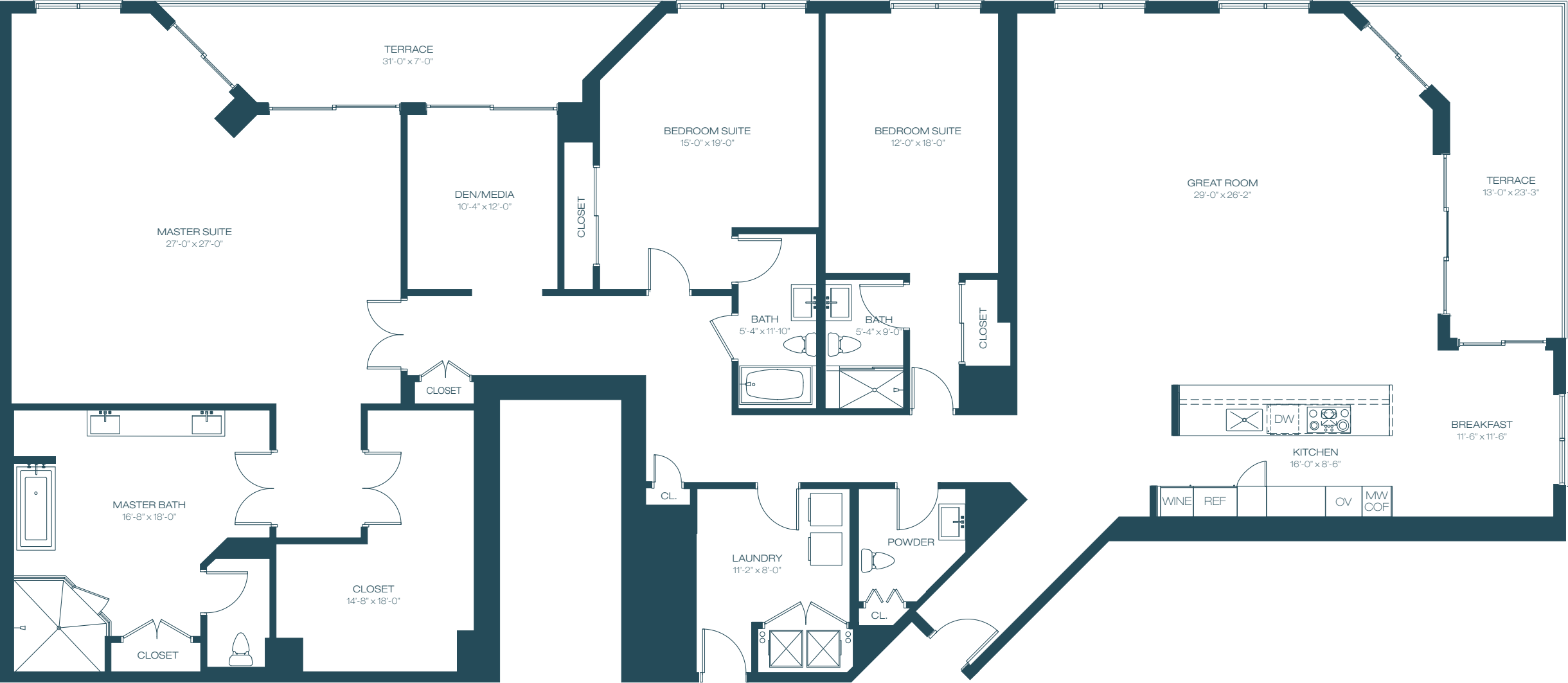
